I. Narrative report

1.1. POLITICAL – ECONOMIC TANZANIA

Tanzania continues to growth with an average growth of 6.5% in the last decade. This has been geared by the high level of exports in natural resources, developments in the tertiary sector (telecommunications, transportation, finance, and tourism) and the establishment of a liberalization programme. Driven by public investment in the infrastructure and energy as well as by household consumption, the GDP reached 6.3% in 2019. However, the outbreak of the COVID-19 in April 2020 slowed down the GDP, it is expected to pick up in this year 2021 subject to the post pandemic global economic recovery.

The government adopted a strategy plan (TDV 2025) Improving public resource management and administration. Long-standing structural problems include mismanagement of public finances and an underdeveloped legal framework that undermines the effectiveness of regulation. Strengthening the economy is based on improving the business environment, increasing

agricultural productivity and added value, improving the delivery of services to build a skilled workforce, good health and better management of urbanization. In addition, the country remains heavily dependent on foreign aid, with almost a third of its budget coming from international aid.

Thanks to various measures taken in previous years which led to better children health and well being. Between 2007 and 2011, malaria affected only 9% of young children instead of 18% (UNICEF, 2014). The Government also took actions to develop access to water, sanitation and hygiene facilities for Tanzania's children though large-scale water and sanitation projects implemented on the Mainland and in Zanzibar.

Nonetheless, Tanzania remains a country highly affected by HIV/AIDS and around 1.3 million people aged over 15 and around 91,000 children below this age are living with HIV/AIDS-related illnesses. Most of these children are orphans and or most vulnerable children.

Kagera Regions, in which Bukoba Diocese is located, has dramatically observed an increased number of sex workers. Though sex work activities are prohibited by the Government and religions, people continue practicing it for their benefits. This has been led by tough economy being experienced today. However, this way happens to increase new HIV infections, leading to loss of people and parents hence an increased number of orphans.

KAKAU has continued supporting School-going Orphans to acquire their Education, not only as a right but as a factor that will save these individual from poverty. The Government has tried its best in regulating education expenses, though not in all perspectives. Government schools have lower fees while private schools charge higher fees. Both private and Government schools coexist because each sector serves a purpose. Government schools cannot accommodate all children. Private schools come in to create more opportunities for children to join school.
